TECHNICAL OVERVIEW

MDFM is a proprietary cloud-native data architecture designed for government finance, organizing data across core dimensions such as funds, departments, grouping, and fiscal periods to support structured reporting and multi-level rollups.

All Gravity environments are hosted on the Google Cloud Platform in the United States, featuring multi-region, multi-zone redundancy. Data is encrypted in transit and at rest. The platform meets SOC1 Type II, SOC2 Type II, and TX-RAMP certifications, and enforces strict access controls, multi-factor authentication (MFA), and full audit traceability.

Unlike traditional data warehouses or data lakes, MDFM is optimized for compliance-first reporting, ensuring referential integrity, real-time propagation of changes, and version control across all Gravity modules.
